

VTCT Level 3 Certificate in Facial Electrotherapy

Who is this course for?

The purpose of this qualification is to develop your skills in beauty therapy/Skincare professional to a high level of occupational ability, to enable you to perform your own salon/clinic services.

What does the course include?

- The knowledge to maintain safe and effective methods of working when providing facial electrical treatment.
- Understand organisational and legal requirements for providing facial electrical treatments
- Understand how to perform client consultation, treatment planning and preparation
- Understand the contra-indications and contra-actions that affect or restrict facial electrical treatments
- Understand how to provide aftercare advice
- Skin analysis- treating a range of skin concerns
- Skin conditions and skin types
- The study of dermatology and microbiology
- Understand anatomy and physiology that relates to facial electrical treatments

Practical professional treatment training in:

- Micro-current
- High Frequency (Direct & In-direct)
- Vacuum Suction
- Lymphatic Drainage
- Electro-Muscle Stimulation
- Galvanic (iontophoresis & desincrustation)
- Microdermabrasion

All products, tools and equipment are provided for the training days at the centre when you attend. No kit is required to complete the training days, nor included in the course fee; however is it advisable to purchase a kit /equipment for your home practical use (case studies). Please speak to your training co-ordinator who can assist you.

Course Structure

This Level 3 Facial Electrotherapy Course qualification theory is completed as home-study, with live zoom sessions, and assignments making this an ideal route for those who wish to study flexibly around other commitments. This will need to be completed before attending your practical training days. Once you have completed all training and coursework, we will arrange for you to attend a multiple choice exam and practical assessment day to achieve your VTCT qualification.

Entry Requirements:

You will need to be 18+ years old. NVQ Level 2 in Beauty Therapy or NVQ Level 2 Facial & Skincare. VTCT/ITEC level 2 award in Infection Prevention (Covid-19) for Beauty Therapy and Nail Services. This can be completed at home at your leisure but there is a small exam to be completed at the centre. This course is free when you register for your qualification but certification is £20. You will also need a good understanding of English to complete your assignments and exam.

Career Progression

All of our courses enable you to work from home, mobile, beauty salon, spas or in clinic offering the specialised treatment(s) that you have completed. You can start earning by offering treatments to paying clients as soon as you have obtained your insurance. Facial treatments are hugely in demand to improve the condition of the skin and minimise the effects of aging. This course will enable you to begin earning well within this lucrative treatment area.

Course Duration:

You will need to complete your home study and assignments before attending your practical sessions (4-8 sessions) which will include demonstrations and guidance. You will need to do 5-10 case studies and return for your practical assessment and multiple choice exam.

How much does the course cost?
