

VTCT Level 2 Award in Facial Massage & Skincare

Who is the course for?

This qualification is for complete beginners or existing therapists, no previous experience required to attend.

This Facial skincare qualification covers how facials are performed professionally. You will learn how to do a professional Cleanse, skin analysis, tone, exfoliation, steam, extractions, a full facial massage and mask application.

You will also learn how to recognise and treat different skin types and conditions. This is a full qualification accredited by VTCT insurable, which allows you to use this massage as a separate treatment on the general public and charge for this therapy.

What will the course cover?

- Hygiene, Health & Safety
- Related Anatomy & Physiology, skin, bones, muscles, blood & lymph of the upper torso
- Equipment and Products
- Preparation of the work area and client
- Contra-indications and Contra-actions
- Client Consultation techniques
- Benefits of Facial Treatments
- Skin Analysis
- Cleansing, Toning and Moisturising
- Exfoliation & Steaming
- Professional extractions
- Mask applications both pre made and tailor made
- Massage Movements & Massage Mediums
- Skin Diseases & Disorders
- Effective retailing
- Aftercare/homecare advice

All products and tools are provided for the training days at the centre when you attend. No kit is required to complete the training days, nor included in the course fee; however is it advisable to purchase a kit for your home practical use (case studies). Please speak to your training co-ordinator who can assist you.

Entry requirements:

You will need to be 18+ years old. No prior experience is required for this course, and it is suitable for complete beginners through to learners that just wish to brush up their skills. Learners wishing to do this VTCT qualification will need to complete the Level 2 award in Infection Prevention (COVID-19) for Beauty Therapy and Nail Services. This can be completed at home at your leisure but there is a small exam to be completed at the centre. This course is free when you register for

your qualification but certification is £20. You will also need a good understanding of English to complete your assignments and exam.

Course structure:

The theory is completed as home-study, with live zoom sessions, and assignments making this an ideal route for those who wish to study flexibly around other commitments. This will need to be completed before attending your practical training days. Once you have completed all training and coursework, we will arrange for you to attend a multiple choice exam and practical assessment day to achieve your VTCT qualification.

Course Duration:

You will need to complete your home study and assignments before attending your practical sessions (2-4 sessions) which will include demonstrations and guidance. You will need to do 5-10 case studies and return for your practical assessment and multiple choice exam.

What will I receive when I complete the course?

Once you have successfully completed the Facial skincare qualification you will receive a VTCT recognised qualification. This will enable you to obtain public liability insurance.

How much does the course cost?

£450 including VTCT registration and exam fees
